#### Bylaws

2022 Bylaws revision reviewed. Main meeting revisions:

- Article IV, 4. Fee for Hole-in-One Fund upon joining and for established members for hole-in-ones the previous year.
- Maintaining the membership roster task moves from Secretary to Treasurer.
- Serve as WA Golf Representative task added to Treasurer.
- Under Treasurer, replace C. "audit" with "review"; revise D. to add "except January, February and November".
- Article VII, 2, replace "prior to elections" with "in April". For 7. begin with "A voice vote to be held unless more than one candidate is nominated".
- Article IX, 3. replace \$100.00 with \$300.00
